Class A = serve 1 earn 1, offender serves 50% of sentence (misdemeanants and Level 6 offenders)

Class B = serve 3 earn 1, offender serves 75% of sentence (not credit restricted, Level 5 and above)

Class C = serve 6 earn 1, offender serves 85.7% of sentence (credit restricted felons)

Class D = earn no credit time, offender serves 100% of sentence
